

# **CALVERT MARINA POOL**

## **RULES AND REGULATIONS**

These rules and regulations are necessary to assure the health, safety and enjoyment of all members and their guests. Failure to comply with any of these rules and/or regulations may be considered cause for suspension or expulsion from the facilities. Before using the pool it is expected that you and each member of your household will read and become familiar with these rules and regulations.

### **ENFORCEMENT**

The Pool Attendant and staff will enforce these rules and regulations. All members and their guests shall obey any instructions of the pool staff. All persons using the pool are expected to show the pool staff proper respect and to cooperate with the staff at all times. Any situations not covered in this document will be handled at the discretion of the Pool Attendant.

### **POOL OPERATIONS**

1. Pool Closings Policy: The Pool Attendant must close the pool for maintenance or health reasons, adverse weather conditions, or any other reason he or she may deem necessary and reasonable.
2. All persons using the pool and its related facilities do so at their own risk. Calvert Marina will not be responsible for any injury nor be responsible for the loss of, damage to or theft of any personal property belonging to a member or guest. Damage to the property caused by the negligent or willful conduct of a member or any person within the member's household will be charged to the responsible member. Members will also be held financially responsible for any damages incurred by their guests.
3. Any person who enters and/or uses the pool facility after the pool is closed will be considered a trespasser and subject to civil liability and/or criminal prosecution.
4. No abusive, foul or profane language shall be permitted within the pool facility.
5. No glass of any kind shall be permitted within the pool facility.
6. The playing of radios is permitted so long as the volume is kept low and it does not annoy others.
7. Any person having grievances or complaints will refer them in writing to the Calvert Marina Office.
8. The Pool Operator will conduct water tests and regulate the equipment and may require everyone to leave the water during this time.

### **POOL ADMISSION**

1. Members and a reasonable number of guests may enter the pool through the front entrance of the bathhouse and must identify themselves to the gate attendant. Members must sign the "members log" and register their guests before entering the pool. No member will be admitted without proper identification. All members must accompany their guest at the pool, when the member leaves, their guests are to leave as well.
2. No child under the age of 14 will be admitted to the pool facility unless accompanied by a responsible adult.
3. Admission shall be refused to any person having a cold, an infectious disease, sore or inflamed eyes, nasal or ear discharges, or any communicable disease of any kind. Persons with excessive sunburn, open sores or bandages of any kind will not be permitted to enter the pool.

### **DAILY GUEST POLICY**

1. Members may bring a reasonable number of friends or relatives to the pool facility.
2. A pool member must accompany all guests during use of the pool.
3. Members are responsible for all actions of their guests.

## HEALTH AND SAFETY RULES

1. All personal injuries, regardless of how minor they may appear, **MUST** be reported to the Pool Attendant on duty.
2. All persons must shower before entering the pool.
3. No pets of any kind are permitted in any part of the pool facility.
4. No shoes may be worn on the concrete areas adjacent to the pool.
5. Wearing of non-bathing apparel in the pool, such as cutoffs, is prohibited.
6. Children wearing disposable diapers are not permitted. (Appropriate "swimmy" diapers are acceptable)
7. Parents are expected to supervise their children while they are in or around the pool.
8. Children under the age of eight (8) may use the pool provided a responsible adult, in the pool itself, accompanies them.
9. Persons who are unable to demonstrate their ability to swim are not permitted in the deep water.
10. Beach toys and equipment such as balls, metal, wood or hard plastic toys, inflated plastics devices, other flotation devices, etc., are **NOT** permitted in the pool. Toys having sharp edges will be confiscated by the Pool Attendant and will be returned upon leaving the pool enclosure. Surf mats may be permitted in the main pool during non-peak hours at the discretion of the Pool Attendant. The use of non-peak hours at the discretion of the Pool Attendant. The use of "nerf" balls is permitted at the discretion of the Attendant on duty.
11. Swim masks, snorkels and swim fins are permitted at the discretion of the Pool Attendant. Only plastic or safety glass tope-face masks will be permitted.
12. No running, diving, jumping or horseplay shall be allowed in or around the pool.
13. All persons must stay clear of the lifeguard stations.
14. Chewing gum of any kind is **NOT** permitted anywhere in the pool facility.
15. All bobby pins, hair pins, and other such materials shall be removed before entering the pool.
16. No skateboards, rollerblades, roller skates, bicycles, other wheeled equipment (with the exception of wheelchairs) or toys are allowed on the pool deck. Children's small pool toys are allowed in the pool at the discretion of the Pool Attendant.
17. **NO GLASS OBJECTS OF ANY KIND** will be permitted within the pool facility.
18. **NO SMOKING IS PERMITTED** within the pool facility.
19. **NO ALCOHOL IS PERMITTED** within the pool facility.
20. **NO FOOD IS PERMITTED** within the pool facility.

## NEW RULES AND REGULATIONS
